



RELEASE OF LIABILITY, WAIVER, CLAIMS, EXPRESS ASSUMPTION OF RISK & INDEMNITY FORM

I, the undersigned (PRINT) _____ in my personal capacity freely accept and expressly assume all risk, danger, and hazards that may arise from my participation in Jackson Park Yacht Club racing, which could result in personal injury, loss of life and damage or loss to property.

RELEASE OF LIABILITY, WAIVER OF CLAIMS & INDEMNITY

In consideration of my participation in Jackson Park Yacht Club racing, as well as the transportation vehicles, use of facilities, and other equipment, provided and/or organized by Jackson Park Yacht Club, I hereby undertake as follows:

- 1. To waive, release and indemnify the Jackson Park Yacht Club and the sponsors of events against any and all claims, however arising, and specifically but not limited to the involvement of myself in the Jackson Park Yacht Club, for any loss or damage resulting from bodily injury, loss of life or loss or damage to property.
2. To release the officials, directors, employees, representatives, agents, sponsors, and volunteers of the Jackson Park Yacht Club from any liability and responsibility, whatsoever, for any claims or caused of action that I, my estate, heirs, executors or assigns may have for personal injury, damage or loss to property or wrongful death arising from my participation in Jackson Park Yacht Club racing, arising from any cause whatsoever.
3. By executing this document, I, in my personal capacity agree to hold the Jackson Park Yacht Club or any persons set out in paragraph 2 above, harmless for any injury or loss of life or damage to property, which may occur directly or indirectly in connection with my participation in Jackson Park Yacht Club racing and indemnify them against any and all claims which may arise in this regard.
4. By signing this undertaking, I am not relying on any verbal or written representation or statement made by the Jackson Park Yacht Club and/or persons set out in paragraph 3 above, other than what is set forth herein.
5. If any provision of this undertaking is found to be unenforceable or invalid, that such provision shall be severed from this contract. The remainder of this undertaking will therefore be construed as though the unenforceable provision had never been contained in this document.

I acknowledge that I am aware of the risks involved in the proposed yachting event. I furthermore acknowledge that I am aware that these are risks to which I am not normally exposed. I voluntarily assume the risks in my taking part in the aforementioned yachting event.

I hereby declare that I am competent and duly authorized to sign this undertaking.

I HAVE READ THIS UNDERTAKING, UNDERSTAND THE TERMS, CONSEQUENCES THEREOF AND AGREE TO BIND MYSELF AND AGREE THERETO.
